The Scottish Episcopal Church General Synod in Edinburgh: 5th to 7th June

The annual General Synod of the SEC meets in Edinburgh next week. Representatives of the clergy and lay people of Brechin will attend as usual. The business includes reviewing the annual work of the General Synod Office support structures, and legal and other governance matters. This has been a time of great change in the staff of GSO, and work will be explored on strategy developments for the whole church. There is a session to explore assisted dying, a matter of concern and interest in Scotland and the UK. There will also be a debate about a declaration of friendship between the Roman Catholic Church in Scotland and the SEC, the 'third leg' of agreements between the Kirk, the SEC and the RC Bishops.

Please keep all at the General Synod in your prayers as they prepare for this meeting to guide and support the life of our church in Scotland. Social media and other updates will be shared as the Synod proceeds.

Assisted Dying: an important matter in our individual and church life

Following the vote last week to start legislation in Scotland to change the law in this area, this is clearly a very important matter in our churches and one which evokes strong emotional responses on both 'sides' of the debate. The SEC was invited to comment on proposals last year, and the relevant committees, on their own behalf, responded. They noted the different views and expressed concerns over adequate safeguards in the legislation https:// www.scotland.anglican.org/response-made-toassisted-dying-call-for-views/. The clergy and lay readers of this Diocese have a planned session to review issues around assisted dying. The General Synod in June is also engaging with these issues.

Please watch this space for further resources and information to inform us as these changes are debated.

Each Vestry Secretary should have received an email from the General Synod Office highlighting an im-


